<u>Taking Action to Prevent Mega-Wildfires in Washington</u> – It's officially wildfire season and by doing our part and educating our friends, neighbors, and coworkers, we really can prevent wildfires this summer. Every resident can begin today with these five small, yet high-impact, actions to prevent wildfires, reduce your wildfire risk at home, and be prepared for a smoke or fire emergency:

- Responsibly start, manage, and extinguish campfires and debris burns.
- Safely use outdoor equipment like lawnmowers and vehicles that can cause a spark.
- Comply with burn bans.
- Remove flammable items within five feet of your home, put screens on vents, and take other measures to build your home's fire resiliency.
- Create smoke readiness and evacuation plans.

We all play an important role in preventing wildfires and doing the above five actions is a good start in preventing them.



Best Practices for Boating on Lake Sawyer

Required Equipment:

- Vessel registration
- Registration numbers properly displayed
- Current license decal properly displayed
- Mandatory Washington State Boating License
- Personal flotation device for each person onboard
- Personal flotation device worn by child 12 years and under if the vessel is less than 19 feet.
- Type IV personal flotation device if the vessel is 16 ft. or over
- U.S. Coast Guard-approved fire extinguisher stored in an accessible place.
- Muffler must be in adequate condition
- Flame arrester must be adequate
- Sound device
- Ventilation/blower
- Carbon monoxide decal
- Orange ski flag (proper display/size)







Courteous Boating Practices

Use caution and respect the other boaters on the water.

Keep it family friendly. Sound travels over water, keep your music at a reasonable level and avoid explicit lyrics.

Skip the hot laps. Avoid traveling in circles around the lake at high speed unless you are towing a skier or wakeboarder. The high velocity waves unsettle the lake unnecessarily.

Water skiers prefer calm water. Wait for them to finish before starting to surf, tube, or use a PWC.

Do not overweight surf boats beyond factory ballast.

Avoid fast turnarounds when a rider or skier falls.

BOAT RESPONSIBLY. STAY ALERT. STAY SOBER.




The legal alcohol limit for operating on water is .08, and for marijuana, it's 5.0 nanograms. Boating impaired is dangerous to others and yourself. To ensure safety, have a sober skipper. Being alcohol-free is the safest way to enjoy the water.

A person shall not operate a personal watercraft in a reckless manner, including recklessly weaving through congested vessel traffic, recklessly jumping the wake of another vessel unreasonably or unnecessarily close to the vessel or when visibility around the vessel is obstructed, or recklessly swerving at the last possible moment to avoid collision. (RCW 79A.60.190)

It is reckless for a PWC to jump the waves behind a boat that is towing a person on a tube, ski, wake or surf board. Please maintain a safe distance from other vessels.

When a boat is towing a person on any device, other vessels should stay at least 100 feet away from the tow boat. When possible, tow boats should stay approximately 200 feet away from the shoreline.

It is unlawful for any motor powered craft to be operated while the propeller is engaged within fifty feet of any swimmer or any row boat, canoe, or other water conveyances on any lake within the city.

No vessel which has in tow a person on water skis, aquaplane, surfboard or similar contrivance shall be operated or propelled in the waters of the city unless such vessel is occupied by at least two competent persons. (Competent shall be defined as a person responsible and capable of alerting the driver of the boat of any activities that require the attention of the driver.) The primary responsibility of the driver is to operate the vessel and the other person will act as an observer of the person in tow. It is the observer's responsibility to immediately inform the driver when a person under tow falls or is otherwise disengaged from the tow boat and to immediately raise a signal flag that is at least twelve inches square of bright orange or red.

Aircraft on the Water

All vessels shall keep clear of aircraft landing within any area now or hereafter set aside by law for such purpose. Aircraft on the water shall keep clear of all vessels and avoid impeding their navigation.



Stand-Up Paddleboards, Kayaks and Canoes

Paddlers 13 years of age or older must have a USCG-approved Type I, II, III, or appropriate Type V life jacket. A child 12-years old or younger must wear their USCG-approved life jacket. A whistle or other sound producing device must be carried.

Kayaks, canoes, stand-up paddleboards, and other paddle-craft are required to stay between the shorelines and buoys during the speeding hours (see QR Code on page 3) when powered motor-crafts are present.

BDMC 8.04.100 – Dates and time common fireworks may be sold or discharged.

- No common fireworks shall be sold within the city except from twelve noon on the twenty- eighth day of June to eleven fifty-nine p.m. on the fourth day of July.
- No common fireworks shall be discharged within the city except between the hours of nine a.m. and twelve midnight on the fourth day of July each year.





Be a good neighbor and remember to pick up all firework debris after your celebration!

REMINDER ABOUT CUTTING TREES

Please call Community Development <u>BEFORE</u> you (or your hired tree cutting service contractor) cuts a tree on your property to make sure you don't require permits. If you live in the vicinity of Lake Sawyer, a Shoreline Exemption may also be needed.
