Proposal	This application proposes to construct multiple intersection improvements to the State Route 169 (SR169) corridor within the City of Black Diamond. Intersection improvements include a new roundabout at the intersection of Roberts Drive / SR169, new right-in/right-out channelization at the intersection of Black Diamond-Ravensdale Road / SR169, and a new roundabout at the future roadway connection to Pipeline Road / SR169. Associated utility improvements include construction of a new stormwater treatment facility, stormwater flow control, enhanced water quality treatment, and new curbs, gutters, sidewalks, and landscaping.

Location	The proposed improvements occur within approximately 1,900 linear feet of the State Route 169 right-of-way, approximately from the intersection of Roberts Drive/SR169 to the frontage of 31329 3 rd Avenue (a/k/a SR169).
