Project Description: Applicant proposes the subdivision of a 32,825 square foot lot with an existing single-family residence into two separate parcels. There is a Level II tree permit associated with this permit.

SEPA Compliance: The application proposes splitting one lot into two. This criterion exempts the project from the SEPA review process per WAC 197-11-800.

Project Documents: Architectural plans, Elevations, Site Plan

Other Associated Permit(s): Level II Tree Permit

Requested Approval: Preliminary 2-lot Short Plat

Applicable Development Regulations: Applications for Preliminary Short Plat are required to be processed as Type 2 land use reviews pursuant to Black Diamond Municipal Code (BDMC) Chapter 18.08. Process requirements for Short Subdivisions are further detailed in BDMC Chapter 17.32.050 as well as 17.15.
