Project Description: The applicant is requesting a minor amendment to The Villages Master Planned Development (MPD) Site Plan and Development Agreement to modify the land uses of Development Parcels V8, V34, V35, V36, V39, V40, V44, V45, V46, V50, V52, V53, V54, V55, V56. This proposal requests to reclassify the following Development Parcels: V8 to Mixed-Use; V34 to low density residential (MPD-L); V36, V39, V50 to medium density residential (MPD-M); V35, V40, V44, V45, V46 to high density residential (MPD-H); and V52, V53, V54, V55, V56 to school use. The density range for residential units within Development Parcels included in this request, as shown on The Villages Development Agreement Table 4-1, will be updated in association with this request. This application does not modify the acreage of the MPD, increase the number of lots proposed, decrease the amount of open space to be provided, or modify the overall design of the approved MPD.

Location: This application impacts the Development Agreement and associated Site Plan for The Villages Master Planned Development and has no physical location. Unaddressed King County parcel numbers associated with this application include 152106-9097, 222106-9037, 222106-9044, 222106-9048, 222106-9051, and 232106-9058.


Environmental Documents: The City has adopted the Final Environmental Impact Statement (FEIS) prepared for The Villages Master Planned Development.
