**Location:** 31231 3rd Avenue, parcel number 112106-9032 (new parcel number would be assigned with Binding Site Plan PLN22-0016), located in a portion of the S1/2 of Section 11, Township 21 North, Range 6 East, Willamette Meridian, King County, Washington.

**Project Description:** This proposal is to construct a Wendy's restaurant with drivethrough and associated site improvements, including landscaping, parking, and utilities. The site is in the Community Commercial (CC) zone and the SR 169 Gateway Corridor Overlay District with a comprehensive plan designation of Community Commercial.

**SEPA Compliance:** This project was determined to be exempt from SEPA review per Washington Administrative Code (WAC) Sections 197-11-800(1)(b)(iv):

The construction of an office, school, commercial, recreational, service or storage building with 4,000 square feet of gross floor area, and with associated parking facilities designed for 20 automobiles. [...]
