Project Description: The applicant is proposing to subdivide four parcels (3.21 acres) within the Ten Trails MPD into 55 lots. Of the 55 proposed lots 16 lots consist of single-family attached residential development, 37 lots consist of multi-family residential development, and 2 lots consist of commercial development. Approximately 1.15 acres are designated as tracts for open spaces, parks, trails, utilities, and landscaping. There are no identified sensitive areas or associated buffers within the plat boundary.

Location: The proposed plat is located within the Ten Trails MPD, north of the intersection of SE Fir Street and Madrona Avenue SE. It is located on unaddressed King County parcel numbers 857600-0730, 857600-0740, 857600-0750, and 857600-0760. The proposal is located within the existing Ten Trails MPD Phase 1A on a portion of MPD Development Parcel V12.

Environmental Documents: The potential environmental impacts for this proposal were assessed with a SEPA Environmental Review under City File Number PLN24-0010. The City issued a Determination of Non-Significance (DNS) for this proposal, which is available for review at the City.

Requested Approval: Preliminary Plat, Type 3 – Quasi-Judicial
