STAFF REPORT ADDENDUM

The purpose of this addendum is to make minor corrections to the Staff Report issued by the City of Black Diamond on December 11, 2023 for the Ten Trails Master Planned Development (MPD) Phase 2 Plat F Preliminary Plat. Two scrivener's errors were included in the Staff Report and are corrected with strikethrough for deleted text and <u>underlined</u> for added text:

- 2. Finding #16 on Page 6 of the Staff Report contains incorrect Dwelling Unit (DU) Ranges for Development Parcels V31, V32, and V33 based on a calculation error. Based on the proposed acreage of Development Parcels V31, V32, and V33, the Dwelling Unit ranges for Development Parcels V32 and V33 should be revised as follows:
