## STATE ENVIRONMENTAL POLICY ACT (SEPA) DETERMINATION OF NON-SIGNIFICANCE (DNS)

**Project Name:** Parks, Recreation, and Open Space (PROS) Plan 2022  
**Location:** City of Black Diamond, WA. The city is located in King County, WA in Sections 2-4, 10-15, 22-23 & 27, Township 21 North, Range 06E

**Description of Proposal:** This project is for the adoption of the 2022 Parks, Recreation, and Open Space (PROS) Plan. This update incorporates 15 years of changes in approach, goals, and strategies to improve the parks and recreation system. Since the last PROS Plan update in 2008, community operations, development, and demographics have changed the landscape of possibilities for the parks program. A steadily increasing population has raised the demand for recreational opportunities; as the City grows in population, there is also a growing need for new opportunities for outdoor activity and engagement. The 2022 PROS Plan includes an in-depth analysis of the performance and quality of Black Diamond's existing park program, goals and policies, a community analysis, public outreach results, vision for the future, funding opportunities, and 6-year capital improvement plan.
