Project Description: The project is a revision to a previously permitted project on the site which was for six commercial buildings. The current project will instead construct four of these same commercial buildings and provide one apartment complex on the same approximate 4.82-acre site. Site development, per prior approvals, began in 2020 and will continue to be developed in phases with complete build out anticipated by 2024. The site has been cleared and graded with a portion of the underground utilities constructed on the eastern portion of the site. The western portion of the site represents the revision and will now contain three apartment buildings. Along with work already completed, the project includes building construction, landscaping, stormwater facilities, water, and sanitary sewer connections to the west side of the site, off-site roadway improvements along 3rd Avenue (SR 169), and franchise utility extensions. Portions of the site and utility work have been completed per prior permitting.

SEPA Compliance: Following review of the submitted State Environmental Policy Act (SEPA) Checklist, an initial evaluation of the proposed project for probable significant adverse environmental impacts has been conducted. The City anticipates issuing a Determination of Non-Significance (DNS) for this project. The optional DNS process, as

specified in Washington Administrative Code (WAC) 197-11-355, is being used. This may be your only opportunity to comment on the environmental impacts of the proposal. The proposal may include mitigation measures under applicable codes, and the project review process may incorporate or require mitigation measures regardless of whether an Environmental Impact Statement (EIS) is prepared. A copy of the subsequent threshold determination for this specific proposal may be obtained upon request.

Process requirements for Binding Site Plans are further detailed in BDMC Chapter 17.34.
