Project Description: The Ten Trails Master Planned Development (MPD) Phase 2 Plat F (referred to as Phase 2F) Preliminary Plat application is to subdivide four existing parcels into 123 lots comprised of 77 detached single-family lots, 4 attached single-family lots, and 42 multi-family lots in accordance with the approved Development Agreement. Approximately 28.93 acres of open space will be provided in tracts within the proposed plat, and will consist of park, open space, sensitive area, trail, and landscape uses. There are identified sensitive areas within the plat boundary and the proposal requests wetland buffer averaging. No direct wetland impacts are proposed.

Location: The proposed plat is located within the Ten Trails MPD, adjacent to the southwest of Ten Trails Plat 2D (referred to as The Regency) along Ten Trails Parkway SE. It is located on unaddressed King County parcel numbers 222106-9035, 222106-9041, 222106-9052, 222106-9053.


Environmental Documents: The potential environmental impacts for this proposal were assessed with a SEPA Environmental Review under City File Number PLN23-0020. The City issued a Mitigated Determination of Non-Significance (MDNS) for this proposal, which is available for review at the City.
